The advance rental for the ROW is determined to be \$1,685.36 for the period from June 1, 2010 to December 31, 2039. BLM has received your advance rental for this period. The rent has been paid to term.

The monitoring fee for this ROW is determined to be a Category II, which is \$392.00. BLM has received your monitoring fee.
